#### The Challenge

Schnellecke Logistics recognized the need for a robust process management solution to meet the diverse requirements of various departments such as quality, IT, LEAN, process management, and compliance. Their existing tool, Signavio, had limitations at that time, being used superficially and lacking company-wide scalability.

Schnellecke lacked visibility into their key processes that prevented the company from taking a globally transparent view of the processes and clearly working out the company-wide dependencies and correlations in order to achieve lean, customer-oriented end-to-end processes.

The company decided to transition to iGrafx to achieve a more comprehensive and globally applicable solution to drive process excellence and risk management.








#### The Solution

The implementation of iGrafx's process intelligence platform, Process360 Live began in 2019 and has since been used worldwide on a daily basis. The platform offers support for all processes within Schnellecke Logistics, offering a centralized and scalable solution.

The comprehensive rollout of iGrafx across Schnellecke Logistics involved the systematic collection of process instructions in Word, alongside thorough audit preparations and consolidation into a dedicated folder for operational employees. Phase 1 focused on recording existing processes, creating dashboards within iGrafx, and implementing shop floor access.





Moving into Phase 2, Schnellecke Logistics expanded its processes to deepen their understanding, incorporating lean training courses, workshops, and additional dashboard development, along with the introduction of QM system houses.

The final phase, Phase 3, facilitated further development of the BPM methodology, expansion of interfaces and tools, and top-down linking of processes and documents. This phase also encompassed the integration of diagrams for value stream mapping, connection of RPA, chatbot, and HR interfaces, and the implementation of risk management.

The completion of Phase 3 marked the culmination of a comprehensive and strategic implementation journey.



As of November 2023, 2,858 diagrams and 18,698 documents have been created at Schnellecke Logistics. This includes the involvement of 18 administrators, 151 key users and 158 process owners.
